

**TSREDCO invites applications from interested stakeholders for
TELANGANA STATE ENERGY CONSERVATION AWARDS 2019 (TSECA 2019)**

In its efforts to encourage energy conservation activities in the State, Government of Telangana presenting Energy Conservation Awards (TSECA) every year on 20th December. As a State Designated Agency of BEE, Telangana Renewable Energy Development Corporation - TSREDCO is implementing this programme. Telangana State Energy Conservation Awards – 2018 (TSECA-2018) were presented by Hon'ble Governor of Telangana State Applications are invited from various stakeholders of following 9 different categories to apply for the award pertaining to the financial year 2018-19 (TSECA- 2019).

- **Category 1: Large scale Industry**
(Including large scale industries –All consumers in the State with a total (electricity + fuel) annual energy consumption more than 1000 TOE (Ton of Oil Equivalent) – Industrial sectors such as Thermal Power Plants, Pulp & Paper, Cements, Iron & Steel, Chlor Alkali, Aluminum, Fertilizer & Textiles etc. may apply under this category.
- **Category 2: Medium scale Industry**
(Including large & medium scale industries – All consumers in the State with a total (electricity + fuel) annual energy consumption between 200 - 1000 TOE
- **Category 3: Small scale Industry**
(Including small scale industries – All consumers in the State with a total (electricity + fuel) annual energy consumption up to 200 TOE)
- **Category 4: Commercial Buildings**
(Commercial Buildings - new & retrofits- including hotels, hospitals etc who have implemented energy conservation/ efficiency programs)
- **Category 5: Government Buildings**
(Government office Buildings- new & retrofits who have implemented energy conservation/ efficiency programs)
- **Category 6: Transport**
(TSRTC individual bus depots may apply under this category)
- **Category 7: Urban Local Bodies -**
(Individual Urban Local Bodies such as / Municipalities/ Municipal Corporations/Water and sewerage Boards may apply under this category)
- **Category 8: Special Category - Energy Clubs in Schools-**
Those Schools who established Energy Clubs and performing the activities for promoting the energy conservation may apply under this category.
- **Category 9: Any Other**
Any efforts towards energy conservation/ energy efficiency by any individual/ institution or organization in the state of Telangana other than above category may apply in this category. Individual applications will not be accepted. The applications for individual efforts must be nominated by any reputed organization other than the working place of the individual.

Any efforts towards energy conservation/ energy efficiency by any stakeholder of the above category in the state of Telangana may apply for this year awards. The qualifying period for the award is the previous financial year from 1st April 2018 to 31st March 2019. However, as conservation efforts require longer period for implementation in some cases, the work in this direction for the immediate past three financial years will also be reviewed. Awards will be presented at a public function on 20th December 2019, during the National Energy Conservation Day and Week Celebrations.
