With reference to the above cited (1), the following revised rates to receive application fee for both Off – Grid and On – Grid systems and TSREDCO administrative charges in Telangana state. The revised fees for both Solar Off –Grid and Solar On – Grid Systems are as follows:-

I. SOLAR OFF – GRID SYSTEMS

S.NO	Category	Existing Application Fee in Rs.	Revised Application fee in Rs.
01	1 - 20KWp	1-5KWp - 1000/- plus 18% GST per KWp	1-20KWp - 1000/- plus 18% GST per KWp

II. SOLAR ON GRID SYSTEMS

Sl. No	Category	Existing Application Fee in Rs.	Revised Application Fee in Rs.
1	1-10KWp	1000/- plus 18% GST per KWp	1000/- plus 18% GST per KWp
2	11-100KWp	15,000/- plus 18% GST per each proposal	
3	Above 100KWp	25,000/- plus 18% GST per each proposal	

III. ADMINISTRATIVE CHARGES OF TS REDCO

3% Administrative charges on the total Work Order value plus 18% GST on Administrative charges	5% Administrative charges on the total Work Order value plus 18% GST on Administrative charges
