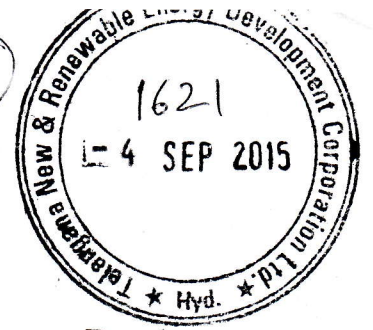

**NOTIFICATION**

The Telangana State New and Renewable Energy Development Corporation Limited is nominated as "Nodal Agency" for implementation of New & Renewable Energy Programmes in the State of Telangana.

The Objectives of the said Nodal Agency are as follows:

1. To Survey, investigate, construct, execute and carryout schemes and works of all kind for the exploitation of non-conventional energy for the development of Agriculture, Industry and Society.
2. To Promote, Establish, Run, Manage, Finance, Develop, Advise, Assist, Aid, Collaborate with any Person, Association, Society, Company, Enterprise, undertaking, institution or scheme for the advancement and development of all Renewable, Non-Conventional Energy Programmes, Power Generation, Conversation, Promotion and development of natural energy through routes of Bio-energy, Bio-Mass, Solar, Wind, Natural Gas, Thermal, Geo-Thermal, Tidal, Mini and Micro Hydel, Animal and Human Energy.
3. To carry on the business as designers, engineers, developers, manufacturers, processors and modifiers, repairers and maintainers, assemblers and installers,

distributors, dealers, stockists, importers, exporters, operators, hirers, leasing producers of and deal in all kinds and types of techniques and technologies, designs, know-how, licenses, materials, chemicals, apparatus, instruments, equipment, devices, tools, components, sub-assemblies, engines or systems and things of all kinds capable being used for or relevant to, energy saving and conservation of non-conventional and renewable energy production, storage, conversion, distribution and operation.
