Energy Department – Policy on Net Metering for Solar Grid Interactive Roof-top and Small SPV Power Plants in the State – Amendment – Orders – Issued.

Dt 27-9-2013 from Chairman/ APPCC & CMD APTRANSCO.

State Government have issued orders for net metering to encourage harnessing of Solar Power through rooftop installations.

2. In the 2nd reference read above, Chairman, APPCC/CMD, APTRANSCO has requested for certain amendment to the policy to encourage the implementation of the above policy. They have proposed for permission to extend Net Metering schemes for single-phase service meters up to certain capacity and provision for bearing of 50% of Net Metering cost for installation of Solar Power system up to 3 KW for those consumers who commission it before 31-03-2014.

3. After careful consideration of the above proposal, Government hereby orders the following amendments to the above orders.

Para 3 (III) shall be read as

“Net Metering facility shall be preferably allowed for 3 Phase service consumers. However, Single Phase consumers are also eligible for Net Metering for setting up Solar Roof-top Systems up to 3 KW”.

A New clause 3 (X) shall be added as follows:

“APDISCOMs will bear 50% of cost of meter for net metering for Solar Roof-top System of capacity up to 3 KW for those domestic consumers who commission it before 31.03.2014.

4. The Chairman & Managing Director, APTRANSCO & APDISCOMS are requested to take necessary action accordingly.
