03. The Interested System Integrators/Suppliers are advised to visit the TSREDCO website of www.tsredco.telangana.gov.in and apply online with required details and attach the required self attested documents.
04. The registration period validity is at the option of Concerned Applicant either 02 years or 01 yr. from the date of approval of TSREDCO.
