ORDER:

In the reference 1st read above, the Hon'ble Minister of Power and Minister of New & Renewable Energy, Government of India, has informed that Energy Transition is the key to reducing our emissions and meeting our Commitments (at National Disaster Commitments(NDC) Conference of Paris (CoP) -26). The first step towards this goal would be to set up State Level Steering Committees on Energy Transition under the Chairmanship of Chief Secretary, Government of Telangana.

2. Therefore the Hon'ble Minister has appealed to constitute a Committee in the State and officers from relevant Ministries in Govt., of India will share the Guidelines with the Committee for the Energy Transition as per our COP-26 Commitments.

3. In the reference 2nd read above, the Vice Chairman & Managing Director, TSREDCO, as per Govt., of India, in consonance to the above have also requested to constitute State Level Steering Committee (SLSC) on Energy Transition, under the Chairmanship of Chief Secretary to Govt., of Telangana and Principal Secretaries of Departments as members, keeping in view of the multi-departmental/multi-agencies efforts are involved.

4. Government after careful examination of the matter, hereby constitute a State Level Steering Committee (SLSC) on Energy Transition, under the Chairmanship of Chief Secretary, Govt., of Telangana, with the following Composition:
